§2

The artist performs in the following line-up:

Type of event: Club concert

The performance time is from 20:30 to approx. 23:00 and lasts at least 90 minutes in two sets The sound check takes place from 18:00 to 19:30.

The organizer will provide a lockable checkroom (non-smoking rooms).

The performance space and checkroom are available to the artists from 17:30.

The artists are obliged to be at the venue in good time so that the concert can begin in time. Exceptions to this are delays or hindrances due to force majeure within the meaning of the applicable laws.

§4

The agreed fee isa fixed net amount of Euro _____ (_____) net. The fee shall be paid as follows: By bank transfer after the concert following correct invoicing by the artist.

§5

The artists shall bear and pay their taxes (income/deduction tax), as well as their insurance insurance contributions (e.g. for accident, illness, disability) and social security contributions themselves.

§6

The organizer is obliged to register the concert with AKM, the artist undertakes to submit the performance list or to complete the relevant form.

§7

The organizer shall provide the artists free of charge:

The equipment specified in the Technical Rider (annex to the contract), a sufficient monitor system, a technically flawless PA system with technician that is sufficient for the venue, a technically flawless lighting system with a technician that is sufficient for the event location. §8

The organizer shall provide _____ overnight accommodation in single rooms with shower/WC and TV in the room for the artists. The costs will be borne by the organizer.

The organizer is responsible for advertising and the resulting costs.

The artists provide digital photos, band information and CDs as support.

The artists are available - by prior arrangement - for interviews as part of the available for interviews as part of the event promotion. Furthermore, the artist undertakes to three months before and two months after the agreed concert not to perform again under their own name in Vienna without prior clarification and approval from P&B.

§10

In the event of a breach of contract, the party at fault shall be liable for all costs incurred. In any case, a contractual penalty in the amount of the agreed guarantee fee shall be paid. In the event of force majeure within the meaning of the applicable laws, the contractual penalty shall not apply. Vienna is agreed as the place of jurisdiction.

§11

The organizer shall provide the artists with 2 tickets/person (up to a maximum of 10 tickets) free of charge. Additional tickets can be purchased by the artists at a reduced admission price.

§12

Without the prior express (written) permission of the organizer, the concert may not be recorded in any form (sound and/or image, neither analog nor digital) and/or broadcast (radio, television and data networks). This also applies to non-public purposes. The organizer has the right to broadcast a real-time live stream via www.porgy.at once only.

§13

Contractual secrecy must be maintained vis-à-vis third parties.

§14

This contract comprises 14 paragraphs on three pages and an annex (Technical Rider). All amendments and agreements must be made in writing and must be signed by both parties.
